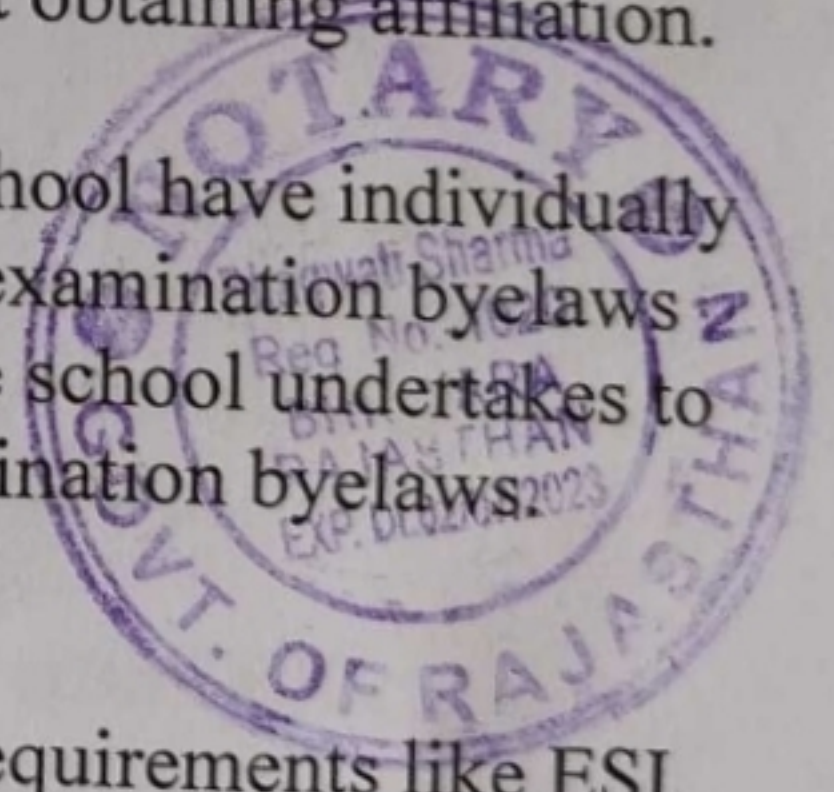
1. That MAHILA ASHRAM, Bhilwara is a registered Society / Trust under the Act 1958.

11. That the school will ensure that sufficient number of qualified teachers/staff/faculty as per the provisions contained in affiliation bye laws are available with the school before starting classes.

12. That the school will follow the provisions related to fee contained in affiliation bye laws and will disclose the details of the fee to the students / parents every year before start of session without resorting to any hidden charge in the heads in the fee.
